BURIAL ON PRIVATE PROPERTY CRITERIA	<p>Attach the following information to the application for assessment:</p> <ol style="list-style-type: none"> 1. Depict on a basic property / site map of the proposed location of grave, 2. Evidence of the applicants relationship with the deceased, 3. A certified copy of each approval required for the undertaking of the burial / funeral (your chosen Funeral Director will be able to provide you a copy of this), 4. Details of how and when the burial / funeral will take place, 5. Evidence of the identity of the deceased person, 6. Evidence of the wishes of the deceased to be buried on this property, 7. Written confirmation from the owner of the property, and anyone else with a registered interest in the land, of permission to carryout the burial on the property, and 8. Details of the nature of the ceremony (if any) to be conducted at the time of the burial . <p><small>*Application for burial on private property must be received a minimum of 3 business days prior to the proposed funeral. The applicant / family are responsible for all grave digging arrangements and costs associated with a burial on private land which must meet Council's grave digging standards.</small></p>
