#### Population and Demographics:

The estimated population of Goondiwindi Regional Council is 10728 AS AT  $30^{TH}$  June 2018, and split evenly male and female. 21.1% of residents are aged between 5-19yrs, 23% are aged between 20-40yrs and 33.5% are 50yrs and over.

26.7 % of community did some sort of volunteer work in the Goondiwindi area in the 12months leading up to 2016 census date.

#### History:

Riddles Oval was taken over as a reserve for sport and Recreation in 1947 and leased by the Goondiwindi Cricket Club. The Goondiwindi Sport and Recreation Association was formed in the early 1960s as a management committee to administer and co-ordinate the sporting facilities of the Riddles Oval Precinct. It has been run by a volunteer committee since that time. Over the years various projects have been run which has made progress of the complex of Riddles Oval successful. With the assistance of the Qld Government a grant was received and the canteen facility and undercover area complete with grandstand seating was constructed on Oval No 2 and also a similar facility at Oval No 1. A canteen area for netball and dressing sheds for all clubs along with updated public toilets were constructed in 2005. A turf wicket is installed on Oval No 1. In 2014 the netball courts were updated to include 4 synpave courts. An internal white picket fence was installed around Oval No 1 in 2018 which has added to the overall appeal and look of the ovals. Refurbishment of a Ladies Toilet and a Disabled Toilet/Parent's Room occurred in 2019. This plan ensures that future development will continue to expand the facilities and improve the playing conditions for all users of Riddles Oval.
