## PLANNING – MATERIAL CHANGE OF USE (MCU)

#### 9.1. EP-070/10 - Issue of Enforcement Notice

At the Technical Services, Planning, Building & Environmental Health Standing Committee Meeting held 8 July 2009, it was resolved to issue a Show Cause Notice under the provisions of s3.2.9 of the *Integrated Planning Act 1997* to the owners of Lots 1 and 2 on SP102869.

The purpose of the Show Cause Notice was to invite the applicant/owner to show cause why an Enforcement Notice should not be given to cease operations until such time as all of the conditions of the development approval have been satisfied.

After discussions with the property owners, they responded to the Show Cause Notice on 11 November 2009, advising that they were attending to the matter.

Further discussions, correspondence and on-site meetings have failed in assisting and persuading the owners to comply with the approval. Therefore the development is found to be unlawful as it is still being carried out in breach of development conditions.

This report has been prepared to allow Council to authorise expenditure associated with the fluoridation of town water supplies prior to receiving full subsidy from the Queensland State Government.

## 10.1.1. Toowoomba and Golden West Regional Tourist Association Ltd - Update

Councillor David McMahon provided a brief update to Council on current issues relevant to the Toowoomba and Golden West Regional Tourist Association Ltd (TGWT):-

- i.) A review is currently underway on the potential merge of regional tourism organisations to one tourism body covering a region including the Southern Downs, Goondiwindi, Stanthorpe areas and potentially up to the Kingaroy area.
- ii.) The Southern Downs Regional Tourist Association is progressing with the merger of the South Burnett Tourist Association and the TGWT
- iii.) A Memorandum of Agreement between TGWT and surrounding councils regarding future funding, etc, is underway.
- iv.) The Annual General Meeting of the TGWT is scheduled for 18 November 2010.

Councillor McMahon suggested Council extend and invitation to the General Manager of the TGWT, to attend the next Portfolio Meeting to provide a more comprehensive update to Councillors and Staff.
